### Investment Objective

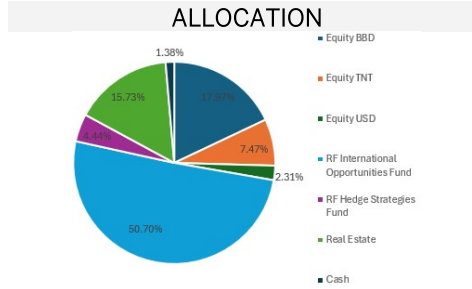

### Fund Features

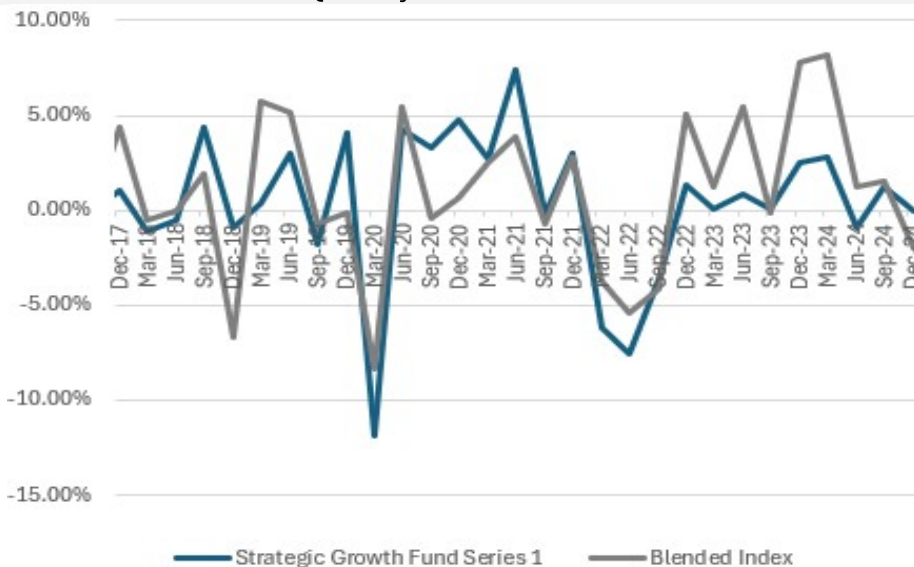
- Diversified across local sectors and companies
